V. LEGAL - Village Attorney Dominick Minerva

At the May 10, 2021 meeting the Board adopted Local Law 5-2021 Cannabis Establishments Opt-Out of cannabis dispensaries and on site cannabis consumption establishments within the boundaries of the Inc. Village of Atlantic Beach - subject to a permissive referendum – no petitions were received and can now be filed with the New York State

Department of State.

GOOD QUESTIONS AND CONCERNS

Residents were able to submit questions/concerns/ comments on the Village Google form. The Google form allowed residents to have an equal opportunity to have a voice and have the questions/concerns answered and shared with the community.

Mayor Pappas read and answered the following received from the residents.

QUESTION: When will the discussed speed bumps be out in? With the beach clubs fully open and traffic coming through the town I think we need to get the speed bumps installed sooner than later. We want the members to understand that they need to slow down and start stopping at the stop signs before someone gets hurt. Living on Atlantic we are able to sit on porch and watch hundreds of cars daily roll stop sign and many heads in cell phones without even noticing kids on the sidewalks.

ANSWER: The Board will be meeting with Denise Ford on timing of lights – will get speed indicators showing traffic. Speed bumps have been received and will be installed. Mayor Pappas said he met with the NCPD. He also asked Silverpoint/Sun and Surf beach clubs and asked them to tell members not to speed.

QUESTION: What is happening with the property they want to build a 3 story Beach Club? Are we

safe from this happening"

ANSWER: Still in limbo – will keep you posted

QUESTION: Is it possible for the Inwood Club and NY Beach Club to have their employees park on

their property. By 9 am all the for everyone spots are taken.

ANSWER: Nothing we can do to prevent parking

QUESTION: There is confusion re what is recyclable. Please consider sending out a mailing itemizing what should be placed in recycle bins. Please explain why glass it not being recycled.
