IV. LEGAL – Village Attorney Dominick Minerva reported that the Village has acquired title to the real property known as 2035 Park Street through Eminent Domain and that the Vesting Order has been filed with the Nassau County Clerk. He also reported that a preliminary injunction was issued by the Federal District Court with regard to the acquisition of 2025 Park Street by Eminent Domain and that proceeding will be on hold pending the outcome of the Federal Litigation.

## **GOOD AND WELFARE**

Residents had various questions and concerns:

- Sidewalk on Park between Ithaca and Jefferson south side have been replaced at the property owners expense per Vincent Amoroso
- Bay Boulevard road in bad condition
- Atlantic Beach Bridge sign says new improvement Mayor Pappas said they are looking into Easy Pass – but yearly decals can still be purchased, not sure of fee;
   Toll plaza will not be taken down
- Eminent Domain questions Village Attorney Minerva said the Board cannot discuss legal strategy in open session in response to questions from the public;
- How will residents be kept up to date on Eminent Domain Mayor Pappas said he will send out letter soon
- Residents sought clarification if the Village now owned 2035 Park Street. Village Attorney Minerva clarified that the Village has acquired title to 2035 Park Street and the advanced payment agreement on the agenda related to the payment for the property.
- The public inquired as to how the advance payment would be paid and the Board indicated that they would bond the acquisition cost.

# RESOLUTION – Winters Bros. Waste Systems – CPI Adjusted Rate

Mayor Pappas said the disposal agreement the Village has with Winters Bros. allows for an annual price adjustment based on the consumer price index (CPI) and the average cost of disposal experienced by the company. The disposal agreement has a maximum allowed price adjustment of 5%. The current published CPI for July, for the Garbage and Trash Collection is 5.2%. Winters Bros. is adjusting the rate 3.5% - the new disposal rate effective August 20, 2022 is \$99.32 per ton.
