PUBLIC HEARING TO AMEND CHAPTER 130 OF THE CODE OF THE VILLAGE OF ATLANTIC BEACH – CHAPTER 130 – LICENSED OCCUPATIONS

Village Attorney Minerva presented the following Local Law:

A Local Law to Amend the Code of the Incorporated Village of Atlantic Beach Chapter 130 entitled "Licensed Occupation", Article I entitled "Gardeners" to add a section 130-3 (D.) providing for a conditional license limiting the Gardener to the use of electric or battery-operated leaf blowers only in consideration for a reduction of the licensing fee.

Be it enacted by the Board of Trustees of the Incorporated Village of Atlantic Beach as follows:

Section 1. Section 130-3 (D) is hereby added with the following language:

130-3 D. The applicant for a license hereunder may apply for a conditional license restricting the use of leaf blowers to electric or battery-operated leaf blowers only in consideration for a twenty-five (25%) percent reduction of the applicable licensing fee. In the event that a licensee elects to obtain the conditional license and utilizes a non-electric or battery-operated leaf blower, it shall be deemed a violation of this Article.

[Added 5-13-24 by L.L. No. __-2024]

Section 2. Full Force & Effect. Except as hereinabove amended, Chapter 130 shall remain in full force and effect.

Section 3. Repealer.

All ordinances, local laws or resolutions, or parts of ordinances, local laws or resolutions of the Incorporated Village of Atlantic Beach inconsistent with the provisions of this local law are hereby repealed, provided, however, that such repeal shall be only to the extent of such inconsistency and in all other respects this local law shall be in addition to other legislation regulating and governing the subject matter covered by this local law.

PUBLIC HEARING TO AMEND CHAPTER 130 OF THE CODE OF THE VILLAGE OF ATLANTIC BEACH – CHAPTER 130 – LICENSED OCCUPATIONS

(Continued)

Section 4. Severability.

If any section, paragraph, subdivision or provision of this local law shall be adjudged invalid or held unconstitutional, the same shall not affect the validity of this local law as a whole or any part or provision thereof, other than the part so decided to be invalid or unconstitutional.

Section 5. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of the State of New York.
