NAT ETROG REPORTS - AUGUST 12,2024

Atlantic Beach Rescue Squad

During the month of July the ABR Squad responded to 51 aided cases, 29 mutual aid to Long Beach and Lawrence/Cedarhurst and 3 water rescue events including victim retrieved from a sinking vessel off of Point Lookout. The ABR Squad will host the 11th annual Nassau County EMS Academy Water Safety Training on August 18th at Eldorado Street and the inlet.

Labor Day is Monday September 2nd. All chairs and umbrellas must be removed from the beach houses on this day. Lifeguards will be on duty for two weekends following Labor Day if weather warrants. Please do not swim if lifeguards are not on duty.

CHIEF LIFEGUARD REPORT - AUGUST 12, 2024

Good evening, I am Dan Majikas, Chief Lifeguard. As we are about 75% through the summer, our staff continues to work diligently to keep our resident beaches as safe as possible. This past week was busy, with high surf and strong currents, indicated by the yellow flags and our lifeguards rescued 3 people in the water. We are using all available resources to monitor the water for hazardous marine life as everyone's safety remains our top priority. As we enter the final three weeks we will see some of our young staff returning to college, which may require the closure of a lifeguard stand during the week. Fortunately our part time staff has been able to accommodate us to remain fully staffed as often as possible, and we have even been able to hire additional guards, following today's ocean test and surf training course.

I would just like to thank Mayor Pappas and all of the trustees behind me for their continued support throughout this season, especially Trish Beaumont, helping us to conduct a successful junior lifeguard program which concluded this past Wednesday with a very entertaining competition. Additionally I just would like to note that we plan on providing lifeguards on the two weekends after Labor Day, evenly spaced between El Dorado, Plaza, Genesee and Putnam beaches.

I'm pleased to report that we are on track to have all our beaches fully staffed for the remaining three weeks of the season, leading up to our closing day on Labor Day.

I would like to take a moment to commend our crew beach attendants and chair personal. They have been doing a phenomenal job, demonstrating reliability and a strong work ethic. Their dedication has been instrumental in maintaining a smooth operation.

I am confident that we will continue to have a safe and enjoyable remainder of the beach season. Thank you for your continued support.

Garden Report

Monday, August 12, 2024

The Village Garden

We've had a busy and bountiful month in the garden.

- **In July we hosted our Fourth Annual Garlic & Shallot Festival. Many thanks to everyone who showed up to support the garden, purchase our home-grown organic garlic and shallots, and all our garden made products, and enjoy our delicious tastings table. We are only one of a handful of Garlic Festivals on Long Island and may in fact be the only one in Nassau County.**
- **The following week, we hosted another one of our favorite annual events, The Children's Harvest. As happens every season, this is a well-attended event with lots of smiling kids pulling their own vegetables and taking inspiration to grow their own veggies at home.**
- **We also continued our weekly harvests and soup kitchen donations. Many thanks to all the volunteers who grow, harvest, and deliver the produce. It's been a bountiful season that's enabled us to share lots of fresh produce with the Long Beach Soup Kitchen.**
- **Mark your calendars for this Wednesday evening, August 14th from 5 to 6 PM. Since we have lots of tomatoes, peppers, and eggplants, we're also able to host a short pop-up farm stand on Wednesday evening from 5-6PM in front of the garden. As many people have expressed an interest in our locally grown, organic, and pesticide free veggies- We do that every couple of years- when we have a little surplus. All proceeds go into garden endeavors and bringing more activities to the community.**
- **And as a Public Service announcement, I want to share an important piece of information from Keith Pearsall, the director of the Atlantic Beach Water Reclamation District, our local wastewater treatment center that operates 24 hrs./day to reclaim our wastewater to meet clean water standards.
The Garden volunteers took a tour of the facilities led by Keith Pearsall.
One of the key pieces of information and biggest problems he said they face is:
Flushable wipes- which do not in fact break down and clog up every part of the wastewater management system, including the grinders and pumps. They recently had

to clean intact wipes from the digester and removed a school bus full at a cost of half a million dollars- If you can avoid using flushable wipes- Please do**
- **Finally to end on a positive note, I want to that the Board of Trustees and the Mayor for considering our letter to restore the \$2500 hundred dollars cut from our budget.**

PUBLIC WORKS

We've hired a contractor to repair various roads in the village with asphalt, patching was done on Jefferson, & Montgomery Boulevards and Lewis Avenue as well as the Jefferson and Dutchess and Plaza beach ends. We also have repaired potholes in various locations throughout the Village. We have other areas of patching that will be taking place in the near future in various locations.

We've had the drainage structures on Bay Blvd between Albany and Broome Avenues aerated and vacuumed out and the sizes of these structures has been conveyed to the Engineer for calculations as part of the drainage improvement project currently in the design phase for improvements to the area.

We have started to have the drainage structures at the tennis center aerated and vacuumed and this work will continue. There is a likely hood that supplemental work may be required to alleviate to reduce or eliminate the collection of water in the area of the parking lot.

The road project on Tioga Avenue from Ocean to Park streets is projected to commence at some point mid/late September. When we know when mobilization and road panel removal installation is going to start, we will deliver a notice the week prior detailing the anticipated work schedule. Access to your homes will be available to you, but there will be times of inconvenience as the project progresses.

All of the Village beaches are being surf raked routinely as part of our seasonal maintenance and we continue with our routine landscaping work throughout the village.

We have been cleaning the Putnam playground with our walk behind surf rake on a once-a-week schedule, as well as the area of the Eldorado playground and the volley ball area.

Our once-a week street sweeping on Tuesdays is continuing. The schedule is available on the village website, please be sure to have your cars off the street by 10 am.

We are continuing to fasten boards on the boardwalk in various locations with the replacement of decking boards as needed.




